FARMERS MARKET PRODUCT LICENSING REQUIREMENTS



Whatever role you serve at your farmers market, we know that you are not only dedicated to ensuring shoppers have access to delicious, locally grown food and other high-quality products, but that shoppers and the products they purchase are safe. Knowing which vendors need to be licensed is an important step you can take to help ensure the safety of the products sold at your market. Licensing requirements for your vendors can depend on the product being sold, how the product is prepared, and gross annual sales. Use the diagram below to determine the general licensing requirements for vendors selling products at the farmers market.



Food that is given away for free, such as samples from vendors or cooking demonstrations, may have different licensing requirements and should always follow the <u>Guidelines for Providing Safe Food Samples at the</u> <u>Farmers Market</u>.

For a comprehensive review of all requirements, review the resources linked in the Other Considerations & Resources tab. Note that in specific instances, other license types may be allowable for some products. You should always consult with and follow the guidance of your area's MDARD inspector on variations from the information provided here.
